#### **Objective and Investment Policy**

#### **Investment Objective**

The Sub-Fund seeks to achieve a mix of income and capital growth by investing mainly in investment grade government or corporate debt securities over a medium term period.

#### Investment Policy

The Sub-Fund is actively managed in reference to the BofA Merrill Lynch Green Bond Hedged Euro benchmark index (the "Benchmark") in order to capture opportunities in the investment grade government, institutions - such as supranational, agencies and quasi-government – and corporate bonds markets. The Sub-Fund invests at minimum one third of its net assets in the components of the Benchmark. 










